Family membership consists of two adults and any child sixteen and under living in the same household.

January 1 – March 31: FEES AS LISTED ABOVE

From **April 1 to December 31** there is a **pro-rated fee** of \$5 per month for a reg. membership or \$7.50 per month for a family membership **PLUS** the membership fee for the next yr. A new member may choose to pay the reg. full yr. fee for the remainder of the current yr. if he or she does not want to take advantage of the discounted fees.

Pro-rated adjusted fee schedule is as follows: **If joining anytime in the month of:**

April - \$95 for reg. membership *or* \$142.50 for family membership (21 month total).

May - \$90 for reg. membership *or* \$135.50 for family membership (20 month total).

June - \$85 for reg. membership *or* \$127.50 for family membership (19 month total).

July - \$80 for reg. membership *or* \$120 for family membership (18 month total).

August - \$75 for reg. membership *or* \$112.50 for family membership (17 month total).

September - \$70 for reg. membership *or* \$105 for family membership (16 month total).

October - \$65 for reg. membership *or* \$97.50 for family membership (15 month total).

November - \$60 for reg. membership *or* \$90 for family membership (14 month total).

December - \$55 for reg. membership *or* \$82.50 for family membership (13 month total).

No discounts will be given for (Juniors age 8- 16 \$10) or (Seniors age 65+ \$25) as they are already at discounted pricing.

The application must be signed before it is processed. By signing and submitting this application the applicant agrees to adhere to and obey all of the current **Rules and Regulations** as set forth by the **Board of Directors** of the Hollidaysburg Consolidated Sportsmen's Assn. (HCSA) to include the **wearing of ear and eye protection** while at any location on HCSA property where firearms of any kind are in use. If applying for the family membership the signatory affirms that the qualifying family members using that membership have been informed of and also agree to adhere and obey the HCSA Rules and Regulations. Violations of the rules and regulations can result in suspension or revocation of that member's HCSA membership with forfeiture of their paid dues.
